Many thanks for your purchase of this Kosher whiskey.


In partnership with the Chicago Rabbinical Council (cRc-Kosher), we produced this Kosher whiskey to carefully adhere to the Kosher Law. Kosher law mandates that whiskey should not be owned or consumed by Jews during Passover. The cRc oversaw the sale of new American Oak Kosher barrels in a contract of sale to me, as a non-Jewish executive of Buffalo Trace Distillery. Once the whiskey reached its desired age earlier this year, the bottling lines at the Distillery were flushed completely beforehand to ensure the whiskey was not exposed to any non-Kosher spirits. So, this whiskey was not released until after Passover.

“We’re excited that our partnership has come to fruition,” stated Rabbi Sholem Fishbane, Kashrus Administrator, Chicago Rabbinical Council. “Our members have shown great interest in the prospect of being able to enjoy a Kosher whiskey. We are very happy Buffalo Trace has taken the steps to make sure this happens.”


